

# Slovenia 2025 Digital Decade Country Report

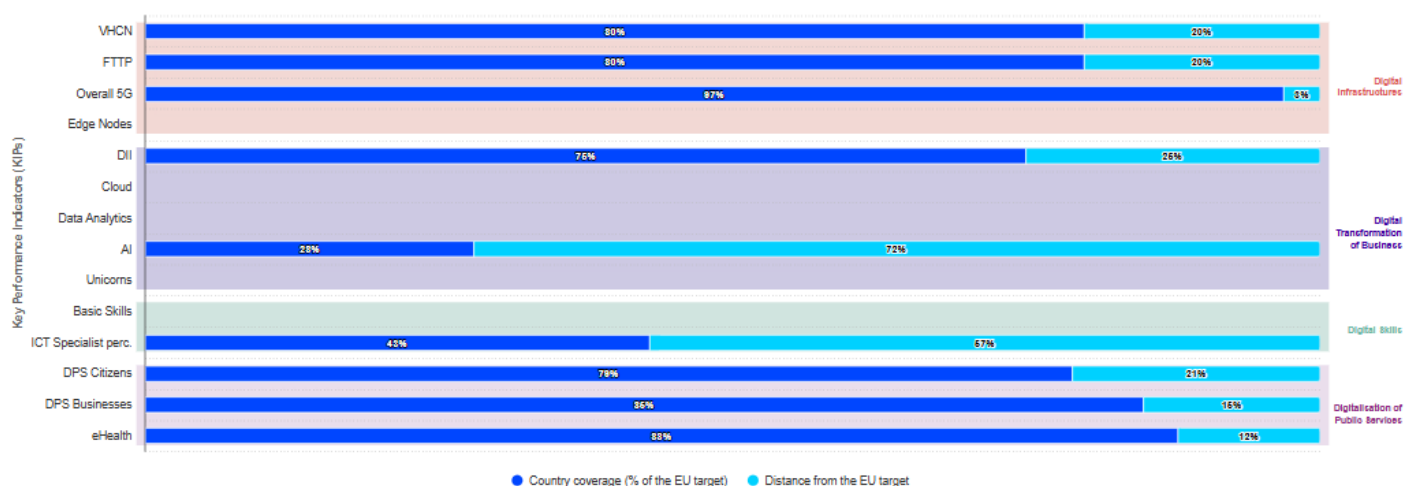
Slovenia's performance towards the Digital Decade targets and objectives.

Slovenia can rely on a **well-developed digital infrastructure** but **lags behind in digital skills**. The country is very active in **several cutting-edge technology projects**, particularly in quantum, semiconductors, cloud and AI.

Slovenia's roadmap is composed of **81 measures** with a budget of **EUR 685 million**, which represents 1.02% of Slovenia's GDP.



## Observed Key Performance Indicators as Percentage of the EU 2030 targets

The graph represents the observed Key Performance Indicators in the Member State as a percentage of the EU 2030 targets, as well as the distance, in percentage, to the EU 2030 targets.

The bars for cloud, data analytics and basic skills are empty, as 2023 is the most recent year for which data is available. The bars for edge nodes and unicorns are also empty as the Member State's performance cannot be compared to the EU target. In 2024, Slovenia had an estimated 16 edge nodes and no unicorns.



## High-performance connectivity and foundational technologies for a competitive EU



**Fibre to the premises coverage** is **relatively high** and **5G coverage** increased significantly.



The country is **very active in strategic technologies** such as quantum computing, semiconductors, cloud computing and AI and **the AI uptake** by businesses progressed significantly.



There is a **relatively low uptake of digital technologies** by SMEs



### Recommendation

Provide continuous **support to SMEs** and create enabling framework conditions for their **uptake of digital technologies**



## Digital skills and public services to protect and empower EU people and society



**Uptake of digital public services** is **above EU-level**.



**The level of basic digital skills remains low**, and the impact of ongoing efforts may not be enough to bridge the significant gaps.



### Recommendation

Increase and intensify education and training offers and integrate digital skills into the education curricula from an early age



Despite good recent progress, Slovenia is still **behind EU average** on **ICT specialists** and addressing **dynamic labour market needs** remains a challenge.



### Recommendation

Improve the early identification of labour market needs and address them accordingly through training offers and with the help of the higher education reform



## Leveraging digital transformation for a smart greening

Slovenia is taking steps to **support the green transition** through **digital technologies**, but there does **not** yet seem to be a **systematic approach** on how to consider their interaction or leveraging each other.



### Recommendation

Enhance digital technologies to support the green transition, in particular by addressing the interaction between green and digital initiatives in a more systematic manner

## What do Slovenian citizens think of digital?

According to the special **Eurobarometer on the Digital Decade 2025**, 78% of Slovenian citizens consider that the **digitalisation of public and private services is making their lives easier**.

90% of citizens consider it important that public authorities mitigate the issue of **fake news and disinformation online**.

82% of citizens consider it important to ensure that European companies can grow and become **'European Champions'** able to compete globally.
